

### **HOSPITAL ACCREDITATION** TIPS FOR COMPLIANT RESPIRATORY ORDERS

Many respiratory therapists (RT) are highly skilled at patient assessment, developing respiratory treatment plans, and managing ventilators. Despite those skills, it is important to know CMS prohibits an RT from rendering services without obtaining an order from a licensed provider who must be privileged to prescribe respiratory services. Survey findings related to respiratory services have been on the rise over the last few years; however, there is a way to have compliant orders that meet regulations and allow respiratory therapists the ability to utilize their skills while remaining within the bounds of order requirements. Here's some tips to help you avoid top findings centered around respiratory orders.

#### Implement SpO2 goal orders

A 2 lpm nasal cannula is clearly ordered; however, the surveyor observes or reviews the medical record to find the patient is on 3 lpm. It may seem like a nickel and dime finding, but it still lands you a survey deficiency for not following the provider's orders. This type of order binds the RT by requiring an order for even a slight adjustment to the flow of oxygen. Instead, consider an order for oxygen therapy to maintain a targeted SpO2 goal so the RT (and nurse) can adjust the flow of oxygen.

#### Ventilator Protocols / Pathways

Another top survey finding stems from implementing ventilator settings, both initial and adjusting settings, without obtaining documented orders from a provider. As a suggestion, organizations should consider range parameters for initial ventilator settings. Be sure to include clear guidance for when to obtain arterial blood gases (ABG) and parameter changes because of the ABG, e.g., PaO2, CO2 goals, etc. Parameters for adjusting settings could also include airway pressures and tidal volumes. Just be clear when providing guidance based on clinical criteria and action to be taken (i.e., if this, do that). To reduce the risks of a survey finding (and RTs practicing outside their scope of practice) consider developing and implementing order sets (sometimes, called protocols or pathways) that meet the following conditions:

- Be algorithmic with clear instructions for interventions (sometimes referred to as a decision tree) to empower the RT with the ability to initiate, discontinue, and restart therapy as warranted by the patient's medical condition.
- Align orders with evidence-based guidelines established by nationally recognized professional organizations such as the American Medical Association, American Association for Respiratory Care, and American Thoracic Association.
- Have the Director of Respiratory Services approve the order set and collaborate with other key physicians for specific situations, e.g., emergency medicine physicians, surgeons, and anesthesiologists.
- Assure an order set is initiated for each specific patient and documented in the medical record. If the physician orders, "RT ventilator protocol," the protocol must be included in the medical record. If you choose to have a standing protocol for initial ventilator settings or managing the ventilator, remember the RT may initiate the order, but a provider (privileged to order respiratory services) must acknowledge and authenticate the order.

#### Be careful with "RT Consult & Treat" orders

Anytime a hospital uses these words, they should be prepared to discuss implementation of respiratory treatment with a surveyor. Instead, consider ordering, "RT Consult," to request the RT to assess and make a recommendation. The word treat will open a door for discussion. Providers and RTs must clearly understand, the RT cannot independently make decisions and "treat" without clear orders from a provider. Some hospitals are in the habit of using the term, "RT consult and treat," as a provider's order to initiate an RT protocol. To avoid a discussion and perhaps an undesirable interpretation by a surveyor, consider using, "RT protocol." Even better, you may want to consider specific RT treatment-based protocols, e.g., oxygen, aerosol therapy, ventilator, etc. On a final and important note - Scope of practice laws for respiratory therapists are defined by state licensing boards. Most states are consistent regarding order requirements but be sure to reach out to the respiratory therapy licensing board in your state. Through communication with your hospitals providers and building order sets that guide decisions, respiratory therapists can be empowered to apply their skills and meet regulatory requirements

## **COMPLIANCE** TIP OF THE MONTH

November's compliance tip of the month is around use of unsafe/unapproved abbreviations in the medical record. Surveyors will cite organizations for the use of unsafe/unapproved abbreviations when they are found in the medical record. The most common use is found in either orders for care and services or on the medication administration record.

Organizations are required to develop a list of unsafe/unapproved abbreviations. It aids organizations if they also implement mechanisms to monitor and identify their use and take appropriate actions to ensure that compliance is achieved and maintained.

The Institute for Safe Medication Practices published the list of error-prone abbreviations, symbols and dose designations for 2024.

This list should be considered as an organization develops or revises their list. It is also recommended that organizations determine specific requirements as defined by State agencies or their chosen accrediting organization
